



INTERNAL REGULATIONS FOR THE CAMPERVAN AREAS OF THE BARR MUNICIPALITIES ASSOCIATION (COMMUNAUTE DE COMMUNES DU PAYS DE BARR)

Having regard to the General Local Authorities Code (Code Général des Collectivités Territoriales) in particular articles L 2221-2, L 2331-2-10°, L 5211-1 and L 5214-16,

With regard to the decision of the Community Council setting the prices for the community areas for the provision of pitches and services for camper vans,

In consideration of the development of community areas for the provision of pitches and services for campervans within the territory of the Barr Municipalities Association,

Whereas internal regulations shall be drawn up governing the operation of these areas offering pitches and services specifically created for camper vans,

Whereas it is for the EPCI (Public Inter-Municipality Cooperation Establishment) to take all appropriate steps to guarantee the proper operation of the facilities and the smooth running of the areas by ensuring the safety of users and the cleanliness of the site,

GENERAL

ARTICLE 1: Parking spaces within the areas and related services are provided exclusively for campervans and motorhomes.

Users of these areas are required to agree to and abide by these internal regulations.

ARTICLE 2: The number of pitches opened within each area for campervans by the Barr Association of Municipalities is set out and displayed on the respective sites. To allow as

many people as possible to enjoy the facilities, stays are restricted to 7 consecutive days, except when special circumstances justify an extension of the use of the pitch.

ARTICLE 3: Fees are charged for parking and for certain services (waste disposal, electricity, water, access to washing and toilet facilities, vehicle wash). The prices are set by the Barr Community Council. Users are required to settle the fees through the pay station.

ARTICLE 4: The pay station accepts payment by bank cards or reloadable prepaid cards.

ARTICLE 5: No construction or fixed facility is allowed on the land, in the pitch where parking is allowed or on the common areas or in any other place.

ARTICLE 6: Users are required to comply with all road signs and with the rules of safe driving. The speed limit within the campsite is 10 kph.

RESPONSABILITIES AND LIABILITIES

ARTICLE 7: Vehicles are driven and parked within the areas at the driver's own risk. Drivers have the same duty of care and responsibility as on the public highway

The right to arrive at, leave and stay in a parking place is granted solely as an authorisation and cannot under any circumstances be considered as a security or surveillance contract. The facilities provided, as well as users' own material, objects and possessions, are used at

the users' own risk and liability, while the Barr Municipalities Association cannot in any way be held liable for any damage arising from the use thereof.

ARTICLE 8: All persons admitted to the parking areas will be held liable for any damage that they may cause or which might be caused by persons under their responsibility, or by animals or objects for which they are responsible and they will be required to make full reparation for any damage caused. Each user must therefore assume individual responsibility for taking proper care of the facilities and will remain liable for any damage they may cause.

RULES OF USE

ARTICLE 9: Pets are allowed but must be kept on a lead and their waste picked up by their owners. Owners will make sure their pets do not disturb the peace of other guests.

ARTICLE 10: Barbecues are allowed with suitable equipment (electric or gas) on the pitches.

ARTICLE 11: Users are required to respect the other guests, notably with regard to noise and cleanliness. Users are also required to comply strictly with hygiene and cleanliness regulations.

ARTICLE 12: Each user is responsible for keeping the area on and around the pitch where they park clean and tidy and not leave any litter or refuse, papers, bottles or packaging. Wastewater may only be disposed of in the facility provided for that purpose.

ARTICLE 13: Domestic waste must be sorted and placed in the appropriate containers provided for that purpose.

FACILITIES AND SERVICES

ARTICLE 14: Mains drinking water is available at the service area for filling up campervan and motorhome water tanks.

ARTICLE 15: Chemical toilets may only be emptied in the tank specifically provided for this purpose. Wastewater can be discharged into the receptacle located by the mains drinking water, which is connected up to the sewage system

ARTICLE 16: Electrical equipment may only be connected using the specific hook-up provided. Users who have opted for an electrical hook-up shall ensure that their connection is safe and secure.

ARTICLE 17 The Barr Municipalities Association is entitled to temporarily close the reception and service areas for maintenance and upkeep purposes, or for reasons of security or public interest.

ARTICLE 18: Any breaches of these internal regulations, as adopted by the Community Council on 23 March 2021, will be recorded and prosecuted in accordance with applicable laws and regulations.
